T LEVEL EMPLOYER INCENTIVE SCHEME

Employers can receive a £1,000 incentive payment for offering a placement to Wave 1 and Wave 2 T Level students.

The allocation letter for November payments was issued on the **15 October**, with payments being made in November based on your enrolment figures in September 2021. Each new T Level student will attract £1,000 to be paid to employers as an incentive payment for offering an industry placement with a start date on or before the 31 July 2022.
